1. Volunteers for Committee Chairpersons. Open positions are Bylaws, Grant-in Aid, Hospitality/Awards.
  - Cheyenne will volunteer to Chair on Grant-in-Aid. She specifically wants to initiate a proposal for Grant-in Aid for classified dependents. Four out of the seven NSHE institutions are participating in a dependent grant-in-aid program.
  - Tasha is interested in Charing Bylaws to address updating because they have not been updated since 2015. Classified compensation and CC executive board stipend are topics of interest for revision. Louellen will help with Bylaws. These two topics will be added to a future Classified Council agenda.
2. Discussion of Back-to-School Event, Krispy Kreme Fundraiser, and Duck Race Themes.
  - Due to the creek not running already this summer, the Duck Race is off this year. Joe Micke in

Health and Safety has approved the Krispy Kreme event fundraiser. Because we are in the middle of outgoing and incoming CC board, no decisions will be made, but ideas for events should be researched.

- Since food events are now allowed on campus, the Fall Soup and Chili Cookoff and Dessert Auction events will be put on the calendar to begin fundraising for the Tony Salvatierra account again.
- Julie suggested a Little Caesar's Fundraising event. This fundraising model is like the See's Candy Fundraiser in which there is no cost to host the event. Cheyenne will complete the interest form for Little Caesar's fundraising.
