**Call Meeting to Order** – Cheyenne Stocks – 10:37 am.

**Treasurer's Report:** Cindy Holt: The Tony Salvatierra Scholarship Account: \$516.48; after disbursement of Spring 2023 Scholarships. The Hospitality Account: \$1304.33; no new transactions. Cheyenne is helping out with getting student emails into PeopleSoft so that they can use the MFA, but there have been some problems for students who aren't taking classes until the future since student emails aren't generated until the students are registered. The Lunch Box is serving all week on campus from their location in the Leonard Center, and they just added smash burgers to their menu that have gotten a lot of positive reviews. There was a Leadership Council meeting yesterday; there will be interviews and forums next week for the search for the Executive Director of Business and Finance position, and the GBC Foundation is hosting their first annual golf tournament this summer.

  - As we get in the last few responses, Cheyenne will finish putting together the data and will be able to present it to Sonja Sibert sometime in the next two weeks when they can get together.
