POSSIBLE ACTION ITEMS:

- Fall Events Discussion: Covid-19 safety guidelines will require conversion of in-person Fall events, such as the Chili Cook-Off, to virtual events. Discussion of potential Boo-Gram or Gobble-Gram fundraisers, flat fee and individual GBC site delivery. Assessment of current COVID conditions will need to be taken into consideration when planning.
- 2. Morale Booster Discussion: Discussion of GBC logo masks, sponsored by CC. Vice-Chair Tasha Storla provided pricing of \$2.20 each, minimum order of 500. Motion to table further discussion of GBC logo masks until Chili Cook-Off fundraiser completion to assess funds: Tasha Storla, Second: Laurie Adams. Motion passes unanimously.
 - a. Chili & Soup Cook-Off
 - Discussion of curbside service or utilization of Sisters Food Service for Chili Cook-Off. COVID guidelines for "no unpackaged food on GBC Campuses" closed this option. Chili Cook-Off Cookbook idea was introduced as an alternative event and fundraiser. Due date of 10/1/20 for recipes to be turned into Media Services for creation of Cookbook. Date of release of Cookbook for sale, 10/26/20. Motion to convert Chili Cook-Off from in-person to virtual event/fundraiser: Sarah Wilkie, Second: Tasha Storla. Motion passes unanimously.
- **3. Tabled Item: Committee Chairpersons/Volunteers:** Responses from current Committee Chairpersons provided by Co-chair Sarah Wilkie as follows:
 - Cynthia/Webpage will possibly be retiring in 2021 so she is open to a volunteer for Webpage chairperson, noting that uploading CC minutes to the CC web page takes minimal time each month
 - Sheree/Grant-in-Aid is happy to stay on Grant-in-Aid; for Events she said she is open to a volunteer or stay on and work with Tasha.
 - **Tiffany/Hospitality and Awards** said she would like to open it to a volunteer. Teresa Campos was nominated by Joe Micke. Teresa accepted chairperson position.
 - Sheymane/Scholarship said she will stay, unless someone else wants to volunteer.
