## New Business: INFORMATION ONLY:

- 1. Updates on the Grant-in-Aid process:
  - Our Classified Family Grant-in-Aid proposal was unanimously approved yesterday at the
    Leadership Council meeting yesterday. Sonja Sibert, who has been helping with the process, was
    also in attendance to show her support and answer questions. President Helens pushed it
    through for a vote to get it implemented as soon as possible.
  - The program will be effective for the Fall 2023 term.
  - Dependents under 24 years old and spouses will be eligible to take advantage of the program on all for-credit courses (not continuing ed./etc.) at GBC. The program is a little different than the one for Classified Staff in that it will cover the state-funded portion, leaving out some smaller costs such as lab fees, and it will allow for up to full-time status (12 credits). Though part time employees and students in the CTE program may see a reduction of benefits since full-time status in their program is 40 credits and the program might not be able to cover everything. There is no minimum requirement for the amount of time that the Classified employee has been working with us in order to be eligible as well.
  - The form has already been sent to HR to check for any revisions that need to be made before it gets posted to the GBC webpage. After it gets posted, we will send out emails and communicate it with our staff.

## POSSIBLE ACTION ITEMS:

- 1. Discussion on upcoming fundraising and events including the Dessert Auction in March
  - The Dessert Auction will be held via the Google Doc on March 16<sup>th</sup> from 10:00am 3:00pm and applicants will have until March 10<sup>th</sup> to reserve their slots.
  - Flyers were put in mailboxes on the Elko campus, and up around the Pahrump campus already. It will also be added to the Weekly Post email starting today.
  - We have one applicant, but hopefully more will start coming in once people have had time to hear about it and plan. We are looking to have 10 entries.
  - Holding an event around graduation time was suggested; possibly the Duck Races since we had kind of been gearing up for that in the past. We have to decided quickly so that we are left with enough time to order things/prepare, so if anyone has ideas about what event we should do please send them to the Executive Committee and we will discuss it further next meeting.
- 2. Election of new officers:
  - Elections will take place in April so that we can have the new officers decided and trained by May and things can be transferred over to the new roles to start in June.
  - We will start the process at next month's meeting.
