## **New Business: INFORMATION ONLY:**

1. Recap of the Dessert Auction, March 16th, 2023:

- There was a great turnout and a lot of interest in the Dessert Auction. In years past, there have been upwards of twenty entries, and we raised more funds this year with less applicants.
- \$470 were raised at the Elko campus, including a \$100 donation from Lynette Macfarlan, and the Ely campus raised \$207 from their bake sale.
- We received a lot of positive feedback from everyone that they were excited that we brought the
  Dessert Auction back and that people had fun seeing and bidding on all the delicious desserts.
  There were fifty bids on our twelve items.
- This kind of event is beneficial because it is simple and easy to do with not a lot of set up since
  the items are donated, but the downside is that it doesn't have the capability of involving the other
  sites.
- We are going to send thank you cards to those who donated entries, and Cheyenne will start looking for some this weekend.

## POSSIBLE ACTION ITEMS:

- 1. Discussion on the plan for the next Classified Council fundraiser/event:
  - People really seemed to like the bidding type of event; it's easy to put on since people can sit at their desks and access the document throughout the time frame instead of having to be somewhere at a specific time. Another theme for this kind of event that was suggested was gift boxes/baskets so that they could be packaged up and sent to the other sites.
  - We don't want to overwhelm people, so we will wait to do another one of these for a little while.
  - The Duck Race was chosen to do as our next event, to be held on May 4th, 2023, with the theme of "May the Fourth"/Star Wars. We don't have as much to put towards it this year compared to years prior, but we already have some research from when we wanted to put it on last year and didn't get to. There will be multiple heats as well as a grand prix. Awards will be given out for winners of each heat and the grand prix as well as for best costume. Entrants can buy ducks for \$5 and enter them in a heat for \$10/heat or in all three heats for \$20. Ducks can be decorated with permeant marker or paints only; nothing offensive. No altering the structure of the duck or additional parts may be added; cannot be a danger to the creek pumps or filters. There have been around 40 ducks entered in prior years according to our records.
  - Tasha will begin creating graphics and advertising, Cheyenne will check into the rules and
    regulations from years prior, Cindy will look into the pricing of ducks and prizes, and Jordan will
    get in contact with Buildings and Grounds to make the reservation and ensure that everything will
    be up and ready to go.
- 2. Election of new officers:
  - We will take nominees at April's meeting and start the election process.
