**Gentlemen:**

We are in receipt of a telegram from Manhattan that Fisherman, Serial 07362, Spud, Serial 07330 and Buck Moore, Serial 06182, Indian applicants for allotments, who have been instructed to file affidavits as to their occupancy of the land applied for, have been unavoidably delayed in getting their affidavits properly prepared. Have wired them to get these papers completed without delay and forward them. These Indians took up their respective lands in good faith for the purpose of making homes for themselves and their families and have been conscientiously improving their holdings. They live at a long distance from any official before whom they can make these affidavits and from persons who can satisfactorily assist them in preparing the same. These various affidavits will no doubt reach the Land Office within a very few days and we trust that owing to the circumstances, their interests will in no way be jeopardized because of this unavoidable delay and that every leniency will be shown them in the matter, especially as they are progressive, law-abiding Indians, who are making honest efforts to build up their own homes.
