

My Friend:

I have your letter of 9th instant, with reference to poor range conditions in your locality, and asking what can be done about the matter.

You will no doubt recall that when I was in Elko it was arranged that I would visit you and other Indians in that section of the State and endeavor to get your water and range rights established. You of course know that the ranges are very poor this year, owing to scarcity of snow and rainfall during the past winter, and it is going to be necessary for all stockmen and ranchers to make the best use possible of the ranges and stock water--preventing overstocking of the range and developing water from springs and seeps so far as practicable.

It is my intention to be down your way in the next week or ten days and when there I would like to see all the Indians and visit their lands, and hear from them just what their difficulties are--whether or not these difficulties can be remedied, etc.

As stated to you while in Elko it will be my desire to help your people in every way possible, and it is always a pleasure to help those Indians who are earnestly trying to help themselves, many of whom are doing well under very great handicaps.

I will try to let you know a day or two in advance of the time to expect me there.
