# 5. PRESIDENT'S REPORT

President Melanie Dodson gave a report for the Early Morning Sweets event that was held on 9/3 for the Welcome Back Week. She stated they were able to give away all 108 donuts. During this time the SGA officers gave out applications for the upcoming SGA elections. She felt that if the social media pages were up and running, they could have had a better turnout. As of this meeting the social media sites are up and being updated.

# 7. TREASURY REPORT

# **INFORMATION**

Student Advocate, Chantell Garcia introduced Sonja Sibert, Vice President for Business Affairs who also serves as SGA Treasurer. Sonja talked about the annual process of changes in student fees, housing fees, course lab fees that require a Board of Regents approval in their December Board meeting. This year there is only one fee that the college administration is looking at increasing. This increase would be effective July 1, 2020. She also stated that the athletics fee that was voted on awhile back for the athletics program was placed on the back burner and it is not in effect. At some point in time they will reintroduce it and students would give their input on this as well. There was a 4% registration fee that went into effect this fall and there will be another 4% registration fee that will go into effect Fall 2020, they were approved by the board previously. Those fees are applicable to all NSHE institutions. She requests support and approval for the proposed increase by college administration in the technology fee from \$4/credit. Possible increases include raising the fee to \$5/credit, \$6/credit, or \$7/credit. This fee would help pay for computers in the classrooms, smart boards, computer labs, Wi-Fi access, overall internet access, software, etc. that students and instructors use in labs. The fee would help to keep the technology as up-to-date as possible for students at the institutions. If the fee was raised from \$4 to \$5 that would be an additional \$60,000 that would come in to the institution. If it was raised to \$6 a credit that would bring in an additional \$120,000. Every student pays this fee as part of the fees that they pay each semester. She asks that the SGA officers have discussions with other students and get feedback from them.

# 8. STUDENT ADVOCATE'S REPORT

Student Advocate, Chantell Garcia stated the election dates are on the webpage in a google document and applications are due by 9/18. Speeches and workshop will be hosted 9/20. She encouraged all officers to reach out to friends and students to get involved. She sent emails to all the Promise Scholars with the application link. She had 5 or 6 students stop by the office regarding joining SGA. She gave thanks to the officers for all their hard work in recruiting students for SGA. She has the google calendar up and said all officers should have access to create and edit events. She has groupme up and has added all officers to

the group. She would like everyone to send media items to Senator Davis for her to add on the social media sites. She stated GBC is doing a Constitution Day 9/17 which they would be doing a table outside the Leonard Center and will be giving away little apple pies, pocket constitutions and would like SGA officers in Elko to participate. In conjunction with Constitution Day, SGA officers will be giving out raffle tickets for the backpack giveaway, winner will be announced at the 9/20 SGA meeting. She brought up the idea of a Black and White movie night and partnering with housing.

# 10. WINNEMUCCA – PIZZA FOR LUNCH WEDNESDAY FOR POSSIBLE ACTION

Senator Marler requested cap of \$15 for supplies and a cap of \$75 for snacks and refreshments for a Snack Week event in accordance to the Welcome Back Week to be held on 9/25. Senator Marler stated they would like to welcome students back with a pizza. Senator Stevens motioned to approve Pizza for Lunch Wednesday. Senator Davis seconded. Motion passed unanimously.
