Sonia Sibert presented the first SGA budget report for the fiscal year.

- The registration fee distribution has been completed.
- The registration enrollment for the Fall 2020 semester is higher than was anticipated.
- There have been few expenditures as of yet.
- The budget item "Operations" mostly refers to events carried out during Welcome Back Week.
- The budget has a very healthy-looking balance of about \$127,000, which is almost two years of revenue partly due to the postponement of graduation because of COVID-19.
- The "NSA Actuals" budget item is an account for the Nevada Student Alliance Activities.

9. WINNEMUCCA BUILDING – FUNDING FOR FURNISHINGS

FOR POSSIBLE ACTION

Sonja Sibert asked SGA to consider funding some of the new furnishings for the Winnemucca building which will provide an area for the community to participate in events at the GBC Winnemucca campus. She provided a summary of the cost estimates:

- \$16,000 conference room
- \$24,000 outdoor areas
- \$68,000 corridors

This building will house the following programs: Health Science, Paramedic, Nursing, and Electrical Technology.

Pat Anderson stated that this would be an opportunity for SGA members to help their fellow students.

Lisa Campbell stated that the study space at the Winnemucca Center is limited and that additional study space would be positive. Having additional parking and lighting will also increase student safety. Senator Sanchez affirmed that, as a student in the Electrical Technology program at Winnemucca, there is limited space, and these improvements would be positive additions.

Sarah Wilkey stated that these changes would be "monumental" for the Winnemucca Center.

President Dempsey tabled the discussion and said that she would send out an email to the SGA members to further discuss this item before putting this item on the agenda for the 10/23/2020 SGA meeting.

Sonja Sibert said she may not be available at the 10/23/2020 meeting to answer any questions but encouraged students to email her with any questions.
