### 5. PRESIDENT'S REPORT

Interim President Stamp completed the PowerPoint for the onboarding process for new senators. He also thanked SGA candidates for joining the meeting. He reminded officers to put any upcoming events on the SGA master calendar.

### 6. STUDENT FEE CHANGES UPDATE

Vice President for Business Affairs Sonja Sibert presented an update on proposed student fee changes. These fee changes are an annual process that go forward to the Board of Regents every December and are put into effect July 1<sup>st</sup> of the following year. An increase in lab fees primarily for welding classes and for ART 101 has been proposed. This increase is mainly due to an increase in cost of supply. VP Sibert provided a spreadsheet, wherein she explained that the amount of increase was the highest possible increase amount, and it may be reduced dependent on a fluctuation in cost of supply. She asked SGA officers to review the material and to speak to students about these changes to gain insight. She also said that she is available for questions and will be present at next week's meeting for the SGA vote.

Interim President Stamp asked what specific supplies has increased in cost and when the student fee changes would come into effect. VP Sibert said that the actual welding materials have increased, and that the changes would come into effect on July 1, 2022.
